## A Saint Louise House Mother Gives Thanks

To the organization that covered my daughter and me for several years I say thank you. To the employees and volunteers who have spent countless hours brainstorming, organizing, making phone calls, and putting their feet to the pavement for us, I say thank you, thank you.

Saturday, October 31 is a day I will never forget; it was move in day. When I dropped off my daughter (3 years old) at day care that day I told her that when I picked her up at the end of the day she would be going home, to our new home and that she would have her own room. The light in her eyes and smile on her face told me that we shared the same excitement. I hadn't seen that light in her eyes and smile on her face in 4 months.

The move in committee is nothing short of super heroes, they thought of everything. There was furniture in the living room, a table in the dining room, dishes in the cabinets, and food

in the refrigerator! Our rooms were furnished, curtains were hung, all the apartment needed was its occupants and we were home. My daughter's room was decorated so well, it was her first room and she was so proud of it from the start. There were toys for her to play with and her first twin size bed. After a quick walk around the neighborhood and trip to the store it was time to prepare for bed and she happily crawled in her new "big girl" bed and drifted soundly off to sleep. At that time my heart was at peace, there were tears but tears of joy.

There are a great many words that come to mind when I think of Saint Louise House, I will only use two, and those are eternally grateful. Our children need roofs over their heads and clothes on their backs, but they need us to be present. Among so many other things, thank you for allowing me to be present!

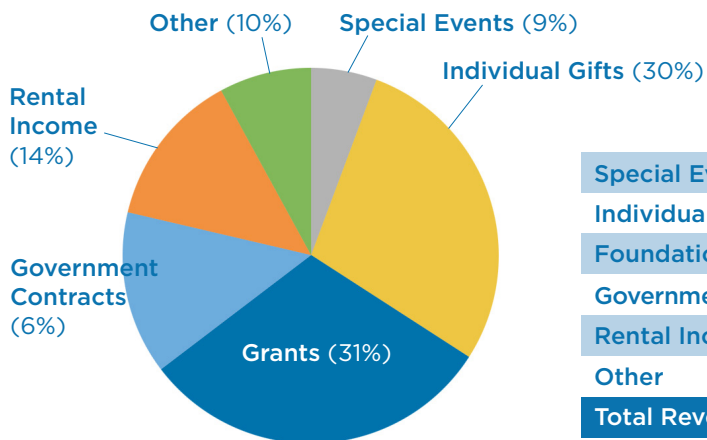

- Women and their children **BUILD** their capabilities as they receive access to income based, deeply affordable housing combined with direct, intense in-home support services that improve employability skills, financial competencies, parenting skills, and self-esteem by building on their strengths and setting goals for growth.
- Families learn to **BELIEVE** in themselves, their capabilities, and the promise of their own futures, and they change the trajectory of their own lives.
- As a family they **BECOME** transformed – ready, willing, and able to leave Saint Louise House and move on to lead successful lives.
- For a total of over 39,000 nights, single women with children previously experiencing homelessness had a place to call home. **SAINT LOUISE HOUSE.**

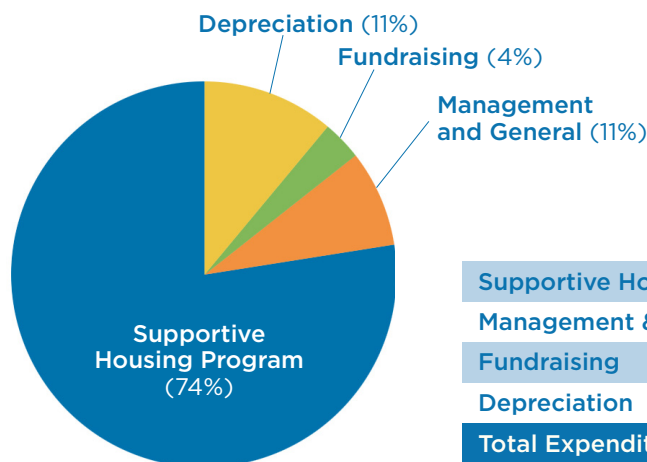
## 2015 REVENUES
